Minutes of the Annual General Meeting of the Gloucestershire Local Optical Committee Tuesday 11th June 2024 at The Leonardo Hotel, Cheltenham

1. Chairs Welcome

Amy welcomed everyone to the meeting.

5. Chair's Report

Amy introduced herself and explained the revised committee structure and sub-groups: Clinical, Communications, Events & CPD and Finance.

Amy reported on a busy last 12 months:

Community Ophthalmic Link was the first in the Country and was going from strength to strength with almost 100% of practices in Gloucestershire having access. Funding had also been approved to continue with the current access and to develop Phase 2 which would facilitate two-way communication.

Low Vision Scheme was now up and running with both domiciliary and practice-based providers.

Unfortunately, funding would not be available for the next year, but it was hoped that some resources might be forthcoming in the future.

Hypertension Monitoring Scheme had been awarded funding in Gloucestershire, details would be shared as soon as possible.

CPD Day 2024 had been booked for 2nd October at Kingsholm Stadium with 15 CPD points on offer. Booking would be open in the near future.

Social Events – the quiz night had been a big success and future events were being planned.

Amy reported that Carole Jenkin had decided to step down from the committee and thanked Carole for her hard work.

6. Treasurer's Report

Nigel noted that LOCSU suggest 6 to 12 months funds should be kept as reserves.

Karen Gennard queried the increase in costs and asked if this was a one off or a similar increase was expected in the next financial year.

Nigel explained the increase was for increased activity, but this was expected to level off and not significantly increase unless circumstances changed. He also mentioned the income for practices from the Enhanced Services the LOC had been involved with was much higher than the levy.

Adrian commented that many areas were not as fortunate with locally commissioned services and Alvaro confirmed many areas are actually losing schemes and felt the more businesslike approach of the committee was very positive in discussions with Commissioners, but these excellent relationships locally took a lot of time and effort from committee members.

Nigel asked for volunteers to audit the accounts and Tony Lawrence and Clare Griffin offered to help.

7. Adoption of the Accounts

The Provisional Accounts were adopted without objection. Finalised accounts would be added to the GlosLOC website with the Minutes.

8. Adoption of the statutory levy including LOCSU Levy for the coming financial year

Nigel proposed the Statutory Levy be increased to 2% - 1.5% for LOCSU and 0.5% for the committee. He reminded the meeting that it was possible for the committee to increase the levy by up to 0.5% but he was not anticipating having to implement such an increase.

The Levy increase was adopted without objection.

9. Election of Committee Members

Nigel Harris, Sid Maher, Ian Shapcott, Adrian Street and Ankur Trivedi were all standing for re-election.

All were elected without objection.

10. Any Other Business
